If your route was not a 47K or 48K, and you were adjusted to a 43K, please contact your steward. Route inspections are like the old way (when they rode with you) except they are using a scanner. During these inspections, you are mapping your route with management. You are marking the box, stop (where you park to deliver), and door; however, packages can still be put in box during these inspections. Rule of thumb, scan where you deliver. This is a time to check your mileage, so please deliver your mail in your line of travel.

The State Convention has already ended. Our guest speaker was the National Director of Labor Relations, Bridget Boseak. In attendance were also USPS North Carolina District Manager, Roselle Murrell, and Manager OPS Integration (District), Amanda Lucas. I hope you all learned something and as first-time attendees saw how changes are made. We may not always agree on issues, but we are able to debate and make our views known. We are still in contract negotiations nationally; however, until we ratify a new contract the old contract is still in effect. The Three Legs of Retirement Success



It's time to get back to basics on what our retirement will be based on.

The first leg of retirement income is the monthly annuity from the post office, and will be based on the highest consecutive 36 months salary and number of good years as a career carrier. To see where your retirement estimate is go to <u>https://liteblue.usps.gov/</u> <u>wps/myportal</u> eRetire (you may have to upload the app the first time). You must be within 5 years of your retirement eligibility date or currently eligible to retire to request an estimate.

The second leg of retirement income is the *Thrift Savings Plan* and it is based on how much and where you contribute your money and the matching contributions, up to 5%, from the postal service.

To check your balance, which fund(s) you are investing or how you are doing go to <u>https://</u>www.tsp.gov/index.html.

Social Security is based on how old you are when you start receiving benefits and how much you earned over the highest 40 quarters during your working life.

Recently I spoke with a customer who is 58 years old and had never set up an online account so he didn't realize what he would receive from Social Security when he reached eligibility age. Please go to https://www.ssa.gov/ and set up your account so you have an idea of what the future benefits could be.

For nearly three years I have written articles about Retirement and have encouraged each of us to have a plan. Another part of your retirement plan should be what are you going to do when you no longer go to work? Some plan on traveling, volunteering in their community or church, spending time with grandchildren and family. Over my Army career taking care of soldiers and talking with postal employees, it's those that don't spend at least 2 days per week involved in something that feel lost when they retire. What ever you choose, please stay engaged in people and life.

Are You Ready For Hurricane Season?

Hurricane season is upon us! The Atlantic hurricane season starts June 1 and the key to minimizing the impact of a hurricane is preparing. While the coastal regions bear the brunt most often when North Carolina has experienced hurricanes, they have had an impact on every part of the state over the past 20 years.

When planning for hurricane season there are some important things that you should consider:

- Have a NOAA Emergency Radio in your home. Vital information is broadcast over weather radio channels that could save your life.
- Have emergency phone numbers written down in a central location and programmed into cell phones.
- Prepare an emergency supply kit.
- Know the locations of or how to identify shelters in your area. Pet owners should note the location of pet friendly shelters.
- Have an emergency plan with your family so there are preset meeting places in the event you are separated, and communications are down.

Your emergency supply kit should contain essentials to get you through the first few days of an emergency. A few things to include are:

- Nonperishable food and drinking water for at least 3 days.
- Emergency medications supply.
- Emergency Power source such as power banks.
- Flashlight (check the batteries).
- Important documents such as wills, passports, and other Personal ID.
- First aid kit and fire extinguisher.

In the event you are in the path of a hurricane you should be prepared to evacuate. Be prepared to take your emergency supplies with you or have your vehicle stocked with the things you'll need in the event an evacuation is called.

Fill your gas tank and park your vehicle in a protected place if you can. If evacuating, follow the appropriate routes and use caution.

DO NOT DRIVE THROUGH FLOODWATER!! Vehicles can be swept away in as little as 6 inches of water and standing water can hide a road washout that could be many feet deep. As the saying goes, TURN AROUND DON'T DROWN!

These are a few tips to get you thinking about hurricane season. There are lots more information sources on emergency preparedness at READY.GOV and the CDC website.

Please be prepared and be safe.

Postal Service Health Benefits Timeline 2024

OPM has approved the RCBP for 2025 and OPM will continue to administer the plan. There are several dates and items coming up that active and retired carriers need to be aware of:

- Open Season is November 11, 2024 thru December 9, 2024.
- Special enrollment period is open April 1, 2024 thru September 30, 2024 for annuitants that would like to enroll in Medicare Part B, without paying penalties.
- Medicare part A and Part D are now required for annuitants.
- Coverage begins January 1, 2025.

The Health Insurance plan is constantly evolving, and I am constantly receiving updates and I will pass those along as they arise.

IMPORTANT

The 3-digit enrollment code will be changing for all Health Insurance Plans. Make sure you login to Liteblue and verify your elections during the open season. You may contact me with questions however, the following websites may provide you with more information.

The first thing I want to say is thank you to everyone that attended our 119th State Convention at Great Wolf Lodge. We had another great convention! There were 199 delegates seated. We had 21 Auxiliary members attend and 104 registered Juniors!

Second, is that we had 49 members that attended the State Convention for the very first time! That is fantastic! We hope that all of you will be back next year.

I hope that everyone felt welcome and that you were able to soak up some knowledge and take it back to your co-workers. Maybe you can encourage them to attend in the future.

Last year we had 54 members that attended for the very first time. We had 34 of them return this year as Second Timers! I am so happy all of you made it back, it was wonderful to see so many of you. Thank you all for coming! I hope to see you at many more of our conventions!

OK, now down to the business of the Convention. I

have included a copy of our financial report that was presented to the delegates. It is on pages 21-24. This is not the final report for the year. Our fiscal year ends on June 30th and our finances will be audited by CPA firm Blake & Sherrill at the close of the year. If you have any questions please give me a call. A final report will be available after the financial audit has been completed.

We had a lot of business to attend to this year.

We had two Constitution changes presented to the body from the Constitution Committee.

Change #1 was to add language to pay some up to \$500 to attend SAC. This failed.

Change #2 was to eliminate the Fall Booster. This also failed.

A 3rd change was proposed under new business. Change #3 was to remove the language requiring the Fall Booster to be moved around the state. This change passed.

We also had seventeen resolutions reported out by the Resolutions Committee. One was binding and the other 16 were non binding. The binding resolution was to have the NRLCA oppose any further implementation of S&DC or R&DC in the country. This failed.

Four non binding resolutions passed. The rest of them failed. The ones that passed were:

1. Whereas currently there is no way to account for large amounts of carrier sort mail received the day after a holiday. Be it Resolved That the USPS,

with input from the NRLCA, develop a reporting program to capture this data from carriers in the field.

2. If an office has received USPS vehicles and those vehicles are not being utilized consistently to run full rural routes, not just for splitting routes, that these vehicles be assigned to routes that are

making multiple trips per day on a regular basis. Further if the office is on a list to receive vehicles routes making additional trips need to be considered for USPS vehicles first.

- 3. As first assured/promised, RRECS data will be available to carriers assigned to a route.
- 4. Offices should be provided with extra scanners during peak season so carriers can be paid correctly when being given auxiliary assistance by a RCA.

We had three resolutions brought up later under new business. Two of those passed. They were:

> 1. PTFs and RCAs if required to work Sundays and/or holidays will be compensated at 150% of their hourly rate for the hours worked regardless of the hours worked for the week.

> 2. That the NRLCA resume and renew their commitment to the Provident Guild and recognize it as a

valuable asset to the NRLCA membership and their spouses.

All of these passed resolutions will now go to National to be presented to the National Delegates. If they pass at the National Convention, then these items will be negotiated for in our next contract.

Legislative Representative

Van Heath

It is now late summer. The 2024 Election cycle is in full swing. Members of Congress are in their districts meeting with you, the voters on an almost daily basis and the majority of commercials on TV and radio are someone saying, "Vote for Me!"

Not a lot is taking place in the Congress, making this a great time to call or write to your member of Congress and to your Senators. Now is when they will pay more attention to what is important to us.

With that said, where do the bills that we are watching stand?

HR 7629, the Protect Our Letter Carriers Act

This bill currently has 81 Cosponsors, and more are signing on each week. I receive two or three emails a week informing me of more members signing on to this bill. We have to get the 218 cosponsors and bring this bill to the floor for a vote before the new Congress takes office in January. If we do not, we will have to start all over again. This bill is important for our safety on the route and for the modernization of the Postal Service.

HR 82/S 597, The Social Security Fairness Act.

We have 320 cosponsors for this bill. Why it has not been brought to the floor for a vote is a mystery.

We now have 7 cosponsors from North Carolina. Back in April, Wiley Nickel (D-13) signed on.

We now need to write to our members; especially the seven cosponsors and ask them to demand that the Speaker of the House schedule this bill for a vote.

HR 3721, The United States Postal Service Equity Act

This is the bill which repeals Prohibition in the Postal Service and would allow us to deliver alcohol just like our competition. This bill may be a lost cause. It is beyond my understanding why Congress would

not give us an equal footing with our competition. There are only 22 cosponsors.

H.R. 5995, the Federal Retirement Fairness Act.

This is the bill that we have been trying to get passed since 1988, that would give us the right to BUY BACK our RCA time towards retirement. We have gained 28 cosponsors in the last couple of months. We are up to 107.

We still only have one cosponsor from our state: Kathy Manning (D-6) and she is retiring at the end of this session. NC District 6 will have a new representative when the 119th Congress is sworn in January.

The only way we are going to get these bills passed is if we write and call our members. There are pre-written letters for all four of these bills on the State and National websites. Send these letters. Ask your spouse and adult children to do the same thing.

.

At the State Convention back in 1997, the previous PAC Chair was stepping down. I went to each member of the State Board and asked for the job. About a month later, State President Rita Gaither called me and offered me the position. I gladly accepted.

I filled that position for twenty years. I have gotten to know members of our Association from all over our state, as well as the entire nation. I have had the opportunity to work in the National Office on PAC projects twice and have taken part in the Annual State Presidents and Vice-Presidents Capitol Hill visits three times.

At the 2017 National Convention in National Harbor MD, I told State President Mitch Reece that I

would be stepping down the next year after our State Convention. I took off a few months before our State President Brenda Gibbs asked me to serve as the Legislative Rep and of course, I accepted.



Membership: Our membership as of June 1, 2024 is 5152 members. In 2023 we had 5114 members.

We had only 4918 members in 2022 on June 1st. On June 8, 2019 we had a high total of 5526

members. We had 5376 on June 20, 2020. We had 5355 members on June 15th in 2021.

As you can see, our membership numbers have only increased a little bit from last year. Your State Board attends as many new hire orientations as we can to recruit new carriers into our membership. Unfortunately 40% of these new hires separated within the year.

Our current membership consists of 2836 regular carriers; 162 PTFs; 1335 relief carriers; and 88 ARCs. There are 722 retired members. We also have 9 associate members.

I have processed 1189 new membership forms this fiscal year. 33 of those were regular carriers. Out of these 1032 new members, 422 of them were RCAs or ARCs that have already separated from the Post Office.

From our membership, we had a total of 59 regular carriers and 735 relief carriers that actually separated from the US Postal Service this fiscal year. These numbers do not include any carriers that were not members.

We had 42 members pass away this year.

There were 36 regular carriers that canceled their membership this year. Fourteen of these have left the craft for management positions.

Non Members: North Carolina currently has 2960 non-members in our craft. There are 1310 regular carriers, 74 PTFs, 1113 RCAs and 463 ARCs that are not members of the union.

I want to remind you that our National office still has the **Recruit A Friend Today (RAFT)** incentive program. You will receive \$15 for each RCA or ARC that you recruit and \$50 for each regular carrier or PTF that joins.

Department of Labor: As a recognized labor union, one of the biggest challenges of the NCRLCA is to deal with matters of law that apply to the NCRLCA and all of its subordinate units. It is the responsibility of the Secretary/Treasurer to comply with these laws by submitting in a timely fashion all required Department of Labor Law reports.

The LM 2, which is the financial report from the state to the Department of Labor (DOL), was prepared at the close of our fiscal year and submitted to the DOL in September. Also, all of our local districts are required to submit a LM 4 report to the DOL within 90 days of the close of the fiscal year. All 31 reports were done by me as the administrator for the districts. Copies were sent to each district secretary to keep with their district records.

All of these reports are of public record and can be seen on the DOL website.

IRS and NC Department of Revenue: It is the responsibility of the Secretary/Treasurer to submit biweekly all taxes withheld from employee paychecks to the IRS and NC Department of Revenue. Annual and Quarterly reports are required to be submitted to each also. All reports were submitted on time as required.

I also have to file the 990's for the State and all local districts to maintain our non-profit status. These are due in November every year. All 990's were filed prior to the due date.

Travel and Meetings: This year I have gone to 27 new hire orientations or rural academy classes for the purpose of recruiting new members to our ranks. I attended our State Convention in June, the National Convention in August, the Fall Booster in November and SAC in January. I went to two local district meetings last fall and six local spring district meetings. We had just one in person board meeting outside of a state meeting. We did have a few teleconference or Zoom meetings as a board. I also met with our Executive Committee on two occasions so that they could do an audit of our books.

I have driven 5143 miles on association business. I had twelve overnight stays this year.

Financial Report: I have meet with our Executive Committee on two separate occasions so that they could do a complete audit of our records. That report will be presented at the State Convention.

The CPA firm of Sherrill, Blake and Harrison reviews our records every year at the close of our fiscal year. A financial report will be printed in an upcoming issue of the *North Carolina Rural Carrier* after that audit has been completed. Please feel free to call me if you have any questions or concerns regarding our finances.

Thank you: I want to thank all of our Stewards; from the local Steward to our District Representatives for all that you do. I am happy to see that we have many new stewards certified in North Carolina.

When needed, please <u>CALL</u> your assigned Steward or Representative.

Procedure to File a Grievance

(See Example PS Form 8191 on next page)

You fill out the sections with red dots (# 1 - 4, except 3b & 3c). Management fills out the sections with the blue dots (#3b & 3c) when <u>you</u> actually file (discuss the issue) the grievance with them. (THIS DISCUSSION MUST BE WITHIN 14 DAYS FROM THE DATE IN 3a).


Once you have filed, let management make themselves a copy and you must get the original to the steward or representative immediately. The steward or representative **only has 10 days** from the date in 3b to setup a meeting with management.

Include a signed and dated statement telling your side of the issue. This statement is for the steward only. Management will not see your statement.

Never hesitate to call your steward or representative with questions if you need assistance. Never put your entire statement in #4 on the grievance form (PS Form 8191). Just state the issue in the form of a single question. Then, provide the steward with a statement explaining your side of the issue.

NOTE: Just filling out a grievance (PS Form 8191) and sending it to the steward or representative is NOT filing a grievance. You must discuss the issue with management at the time you are filing the grievance and follow the proper procedure.

Management must fill out sections 3b & 3c.


